114 Commercial St. is a 2-story, 5-bay Italianate-style dwelling; side-gable roof is sheathed in asphalt shingles, interior brick chimney on front roof slope, wood cornice with partial returns; exterior is clad in wood shingles with aluminum trim, building sits on a brick foundation; fenestration includes 1/1 vinyl DHS, Chicago-style picture window to left of door has 1/1 DHS, storm windows, inoperable louvered shutters; primary entrance is accessed by a panel door with 4 lights, flat door hood with wood modillions and pendants, brick stoop; rear ell has entry on side facade and also at 2nd story in gable end, interior brick chimney at roof ridge, exterior wood staircase; 1-story, shed-roof addition extends from ell's side facade; offset rusticated block foundation.
