23 Watson's Court is a 1-1/2-story, 3-bay sidehall dwelling; gable-front roof is sheathed in asphalt shingles; interior brick chimney at peak; exterior is clad in wood shingles with wood corner boards and trim; fenestration includes 2/2 wood DHS with wood surrounds; shed dormer on south slope with 1/1 DHS; entrance has pane-and-panel wood door with modern storm door; door surround has pilasters and heavy entablature; accessed by step down from driveway onto wood deck; rear extensions with entrance on south, 6/6 wood DHS on north side, and exterior concrete block chimney .
