### ARCHITECTURAL DESCRIPTION

1 1/2-story, 4-bay; entire front facade covered in vines and ivy; asphalt roof shingles; shed dormers on each slope with no windows; primary entrance is decorative pane and panel door with marble step, flat hood supported by decorative brackets, 3 gold dolphins above door; fenestration includes 12-pane wood fixed, 6-pane wood fixed, windows in gable not visible due to vine, windows on side facades have snap-in muntins and art glass spheres.
