#### ARCHITECTURAL DESCRIPTION

91 Bradford Street is a 1-story, 4-bay, Greek Revival-style 3/4 cottage; the side gable roof is clad in asphalt shingles, a brick chimney is centrally located at the roof ridge.; the exterior is clad in wood shingles and the foundation is obscured; the fenestration includes 1/1 wood DHS with modern storms and flanking inoperable louvered shutters; The primary entrance has a modern slab door with storm and flanked by 4-light sidelights, with an elaborate surround covered in vinyl accessed by a small wood landing with side rails accesses the front door from the sidewalk; A secondary entrance is located on the side façade, and it is reached by wood stairs and modern landing.
